

## Village of Timberlane Illinois

Ordinance No: O08-353-01

An Ordinance levying taxes for all corporate purposes for the Village of Timberlane, Boone County, Illinois for the Fiscal Year commencing on the 1<sup>st</sup> day of January, 2009 and ending on the 3<sup>rd</sup> day of December, 2009.

BE IT ORDAINED by the President and the Board of Trustees of the Village of Timberlane, Boone County, Illinois:

Section 1: That the amount hereinafter set forth, or so much thereof as may be authorized by law and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Audit, Insurance, and Street Repair for the fiscal year of the said Village of Timberlane, Boone County, Illinois, beginning on the 1<sup>st</sup> day of January, 2009 and ending on the 31<sup>st</sup> day of December, 2009.

Section 2: The amount levied for each object or purposes is as follows:


