

## **ORDINANCE O011-230 1**

### **AN ORDINANCE CHANGING A ROADWAY NAME IN THE PRAIRIE LANE, THE PRESERVE SUBDIVISION**

**WHEREAS**, the Village of Timberlane in desiring to protect the health, safety and welfare of it's residents desires to correct a long standing road name conflict within the Prairie Lane, The Preserve Subdivision, and

**WHEREAS**, the platted road name of Arboretum Drive is in conflict with the long standing name of Carbineer Drive currently in use by 7 (seven) residential property owners, and

**WHEREAS**, a short stub road connecting Arboretum Drive in Prairie Lane, The Preserve Subdivision from the Hidden Grove Subdivision existed prior to the Platting of subject subdivision, of which road is named Carbineer Drive, and

**WHEREAS**, in previous years the developer of subject subdivision had marketed and sold certain lots on a length of Arboretum Drive to be addressed as Carbineer Drive, and

**WHEREAS**, the subject residential property owners request to continue the use of the road name Carbineer Drive instead of the platted road name of Arboretum Drive,

**NOW THEREFORE, BE IT ORDAINED** by the President and the Board of Trustees of the Village of Timberlane, Boone County, Illinois that:

**Section 1. Prairie Lane, The Preserve Subdivision.** The Platted Road Name of Arboretum Drive is hereby changed to Carbineer Drive for the following properties:

Lot 55, 3345 Carbineer Drive  
 Lot 56, 3349 Carbineer Drive  
 Lot 57, 3365 Carbineer Drive  
 Lot 58, 3369 Carbineer Drive

Lot 59, 3371 Carbineer Drive  
 Lot 60, 3374 Carbineer Drive  
 Lot 61, 3368 Carbineer Drive

**Section 2. Hidden Grove Subdivision.** It is further acknowledged and approved that the following residential properties within Plat #2 of Hidden Grove Subdivision shall continue to use the platted road name of Carbineer Drive:

Lot 32, 3380 Carbineer Drive

Lot 33, 3390 Carbineer Drive

**Section 3. Evidence.** A copy of excerpts of the subject plats and of the official Boone County Address Map are attached and made a part of this ordinance

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.


**This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.**
